RESOLUTION OF THE CUMBERLAND COUNTY UTILITIES AUTHORITY DECLARING ITS OFFICIAL INTENT TO REIMBURSE EXPENDITURES FOR PROJECT COSTS FROM THE PROCEEDS OF DEBT OBLIGATIONS IN CONNECTION WITH ITS PARTICIPATION IN THE 2016 NEW JERSEY ENVIRONMENTAL INFRASTRUCTURE TRUST FINANCING PROGRAM

WHEREAS, the Cumberland County Utilities Authority (the "Borrower") intends to acquire, construct, renovate and/or install the environmental infrastructure project more fully described in <u>Exhibit A</u> attached hereto (the "Project");

WHEREAS, the Borrower intends to finance the Project with debt obligations of the Borrower (the "Project Debt Obligations") but may pay for certain costs of the Project (the "Project Costs") prior to the issuance of the Project Debt Obligations with funds of the Borrower that are not borrowed funds;

WHEREAS, the Borrower reasonably anticipates that obligations, the interest on which is excluded from gross income under Section 103 of the Internal Revenue Code of 1986, as amended (the "Code"), will be issued by the New Jersey Environmental Infrastructure Trust (the "Issuer") to finance the Project on a long-term basis by making a loan to the Borrower with the proceeds of the Issuer's obligations (the "Project Bonds"); and

WHEREAS, the Borrower desires to preserve its right to treat an allocation of proceeds of the Project Debt Obligations to the reimbursement of Project Costs paid prior to the issuance of the Project Debt Obligations as an expenditure for such Project Costs to be reimbursed for purposes of Sections 103 and 141 through 150, inclusive, of the Code.

NOW, THEREFORE, BE IT RESOLVED by the governing body of the Borrower as follows:

- **Section 1.** The Borrower reasonably expects to reimburse its expenditure of Project Costs paid prior to the issuance of the Project Debt Obligations with proceeds of its Project Debt Obligations.
- **Section 2.** This resolution is intended to be and hereby is a declaration of the Borrower's official intent to reimburse the expenditure of Project Costs paid prior to the issuance of the Project Debt Obligations with the proceeds of a borrowing to be incurred by the Borrower, in accordance with Treasury Regulations §150-2.
- **Section 3.** The maximum principal amount of the Project Debt Obligations expected to be issued to finance the Project is not to exceed \$2,100,000.
- **Section 4.** The Project Costs to be reimbursed with the proceeds of the Project Debt Obligations will be "capital expenditures" in accordance with the meaning of Section 150 of the Code.
- **Section 5.** No reimbursement allocation will employ an "abusive arbitrage device" under Treasury Regulations §1.148-10 to avoid the arbitrage restrictions or to avoid the restrictions under Sections 142 through 147, inclusive, of the Code. The proceeds of the Project Bonds used to reimburse the Borrower for Project Costs, or funds corresponding to such amounts, will not be used in a manner that results in the creation of "replacement"

REGULAR MEETING CUMBERLAND COUNTY UTILITIES AUTHORITY January 15, 2015

The Cumberland County Utilities Authority (CCUA) held its Regular Monthly Meeting on Thursday, January 15, 2015 in the Meeting Room of the Operations Building, 333 Water Street, Bridgeton, New Jersey.

Chairman Jones called the meeting to order, announced that adequate notice of this meeting has been given in accordance with Chapter 231, P. L. 1975 (THE OPEN PUBLIC MEETING ACT) and led in the flag salute.

Secretary Hill called the roll and a quorum was present. Commissioner Sam Boutros was recorded as absent.

Chairman Jones called for a motion to approve the minutes of the Regular Monthly Meeting of December 18, 2014. It was motioned by Commissioner Bethea, seconded by Commissioner Friedman and was carried unanimously at roll call.

REPORTS

Director

Director Errickson submitted the December 2014 Discharge Monitoring Report (DMR) for inclusion in the minutes of this meeting. The Authority met all discharge parameters for the month of December. The plant inspection was held by DEP on December 16, 2014. While there is always a few minor details they want addressed, the inspection went well overall.

Our lab inspection is scheduled for February 9, 2015. It was noted that we will begin working shortly with key employees to move towards electronic reporting for all permits.

He reported meeting with Tony Rivera from the CCIA, to discuss renewal of a inter-local service agreement for Hazardous Waste Days. This agreement allows us to conduct three household hazardous waste clean-up days for residents of Cumberland County, thereby serving the needs of county residents and at the same time diverting hazardous material away from county and local sewerage treatment systems. Also discussed was a new agreement with CCIA regarding (RCP) "Recycling Collection Program" that includes paper,

newspaper, magazines, aluminum cans, tin cans and plastic, but no food waste. Mr. Rivera is going to attend one of our plant employee meetings to explain this new program and answer any questions that may arise.

Director Errickson noted that he and Deputy Director Fernandez attended a meeting with NJEIT in Lawrenceville NJ to discuss means and methods necessary to develop infrastructure projects at the Bay Shores of Cumberland County. A number of elected officials and county administrators also attended this discussion and gave their input. In his opinion, funding will be the biggest challenge, not the engineering. Federal Sandy Relief Funds or some type of grant money will be needed in order to move projects forward.

Director Errickson informed the Board that the GCUA incinerator remains down, and we are taking sludge to ACUA. GCUA hopes to have their incinerator back on line by the end of January, or first two weeks of February. However, in the long term, they are moving ahead with the construction of digesters, at which time they would no longer accept sludge cake. While this is still some years down the road, it does mean that the Authority needs to evaluate sludge management options for the future.

He also noted that discussions continue with NJ Ethanol on their draft permit. We have asked for detailed plans on the pretreatment system and piping but have only received a generic plan from the manufacturer.

The Authority's plant discharge permit application was submitted in August, but to date, have had no comments back. Staff is currently working on the annual pretreatment reports for EPA and DEP. In addition, the Authority's land application permit package was submitted the end of December, and we are currently working on our end of year annual sludge management reports for EPA and DEP.

Director Errickson offered a brief summary regarding the resolutions on today's agenda. Resolution "A" is to purchase material according to terms of NJ State contracts. Resolution "B" deals with contract renewal with PTP Consulting for professional services related to health and safety training. Resolution "C" is for the Inter-Local Service agreement with CCIA for household Hazardous Waste clean-up days. Resolution "D" is for the Re-appointment of Deputy Director for CCUA. Resolution "E" is a resolution honoring Donald Olbrich for his years of service. Resolution "F" will allow the CCUA to be reimbursed by the NJEIT for cost associated with up and coming Authority projects.

In conclusion, Director Errickson again offered his thanks to Deputy Director Mike Fernandez, Administrative Assistant Patti McAllister, Business Administrator Karen Davis and Authority Engineer Jerry Harris for their help with preparing his reports and for their dedication and hard work throughout the year; all together it is a great team.

Engineer

Mr. Harris reported that initial activities are underway relative to the design of the 2016 NJEIT Projects which are the upgrade of the Upper Deerfield (Seabrook) Pumping Station and miscellaneous improvements to the Wastewater Treatment Plant. A kickoff meeting with CCUA Staff was held on December 15, 2014. The meeting consisted of site visits to the Upper Deerfield Pump Station and the CCUA Wastewater Treatment Plant. Project objective is to have "permit ready" plans and specifications prepared by March 6, 2015 for submission to the NJDEP/NJEIT.

He also noted that there has been no activity on the review of the Wastewater Discharge Permit Application, submitted by New Jersey Ethanol, LLC.

Auditor

Mr. Testa was not required at this meeting, therefore no report.

General Counsel

Mr. O'Donnell reported that the delinquent hauler the Authority had a judgment against, recently filed for bankruptcy protection. While it was an individual bankruptcy, it is unlikely the corporation had any individual assets, but he will reach out to the attorney. Of note, the hauler owed the IRS in excess of six figures, as well as other security creditors, who would be in line ahead of us.

Mr. O'Donnell also reported the case involving the failed tank work has been sent to mediation by the court. It is anticipated that the Director, Engineer and myself will meet with the contractor and his attorney to see if a resolution can be reached first.

Mr. O'Donnell stated that, as always, he was available to answer questions and concerns from staff or commissioners.

Committees

The Chairman's Committee, met on January 12, 2015 to discuss the re-appointment and employment contract for Deputy Director Michael Fernandez. The Committee recommends approval of the re-appointment of Deputy Director A. Michael Fernandez under the terms and conditions specified in his two (2) year contract. A copy of the minutes of the meeting is included in the Commissioners packets.
