REGULAR MEETING CUMBERLAND COUNTY UTILITIES AUTHORITY October 16, 2014

The Cumberland County Utilities Authority (CCUA) held its Regular Monthly Meeting on Thursday, October 16, 2014 in the Meeting Room of the Operations Building, 333 Water Street, Bridgeton, New Jersey.

Chairman Jones called the meeting to order, announced that adequate notice of this meeting has been given in accordance with Chapter 231, P.L. (THE OPEN PUBLIC MEETING ACT) and led in the flag salute.

Secretary Hill called the roll and a quorum was present. Commissioner Sam Boutros was recorded as an excused absent.

Chairman Jones called for a motion to approve the minutes of the Regular Monthly Meeting of September 18, 2014. Motion was made by Commissioner Bethea, seconded by Commissioner Olbrich and was carried unanimously at roll call.

Chairman Jones called for reports.

REPORTS

Director

Director Errickson submitted the September 2014 Discharge Monitoring Reports (DMR) for inclusion in the minutes of this meeting.

The Director reported that Time and Technology Inc. was on site this month to perform a property evaluation for the City of Bridgeton.

The Director also reported that training for employees to perform CPR was held this past month.

The Director further reported that a renewal application for insurance has been submitted to the County Insurance Group earlier this month and we are waiting for our new policy.

He also informed the board that he met with Salmon Ventures Inc. and NJ Energy Coalition to discuss Solar Energy and possible energy saving methods for the Authority.

The Director informed the Board that the contract for natural gas is about to expire and we plan to join with the County in holding a "Reverse Auction" for natural gas in order to reduce utility costs.

The Director continued his report, noting he visited the Upper Deerfield pump station with Authority staff and Engineer Jerome Harris to discuss the preliminary design of the station replacement.

Director Errickson informed the Board that we had been invited to meet with the Cumberland County Planning Board and present a concept design to install sewer lines from the Authority plant to the County Bay Shore area. The presentation was met with favorable response. Deputy Director Michael Fernandez and Carl Gaskill did a great job with the presentation.

Director Errickson also noted that a county wide technology meeting was held at the Freeholder Conference room this week. Discussions centered around shared service with current operations, also networking computers and telephones.

The Director informed the Board that the bid opening for a new Roll Off Container Truck took place this week. We have certified results, with delivery within 160 days of award. This would mean delivery would be sometime in April or May of 2015.

The Director reported attending the ground breaking ceremony for the future Vo-Tech School on September 17, 2014. The Director feels that this is a positive move for Cumberland County and will also help the CCUA by giving them a resource for qualified workers in the future.

The Director reported that he has had some discussion with Atlantic City Electric regarding Solar Energy use at the CCUA. In the past it appeared not to be possible, but we have some new ideas that we passed on to Atlantic City Electric and they are at least for now reconsidering the whole idea. The Director will keep the Board informed as things develop.

Director Errickson reported meeting with Fairfield Township Tax Collector, Carla Smith this past month regarding billing questions which were addressed.

The Director also informed the Board that the CCUA has submitted a Letter of Intent with the New Jersey Environmental Infrastructure Trust. This is our application for loans for future projects. Examples of the projects would be the Upper Deerfield Pump Station and plant improvements.

Director Errickson reported that we are continuing to apply sludge at Cumberland Nurseries for our final fall application. The previous problems with methane gas production appear to have been resolved after a water blockage was cleared.

Director Errickson reported that we had an exceptional plant performance during September 2014, with Biochemical Oxygen Demand (B.O.D.) and Total Suspended Solids (T.S.S.) discharges being in the single digits.

The Director also informed the Board that a draft permit was issued for the proposed NJ Ethanol facility at the Bridgeton Industrial Park. They indicated they had some questions but have not followed up with any specific issues.

The Director went on to inform the Board that we continue to monitor the discharge from the Cumberland Manor nursing home, due to previous issues.

Director Errickson also noted that Deputy Director Fernandez was the presenter on performance of our sludge screw presses at the Operator Technology Transfer Seminar a few weeks ago. Mr. Fernandez is also researching our old files for anything related to sludge management for the 100th anniversary of the NJ Water Environment Federation that will be held in Atlantic City in May 2015.

The Director noted that we have several resolutions on the agenda tonight: Resolution "A" deals with the Introduction of the 2015 Budget. The Finance and Budget Committee will give a recommendation on this. Resolution "B" is Authorizing Public hearing on Amendments to the Sewer Use Rules. Resolution "C" extends the contract with Kuehne Chemical Company for supply and delivery of sodium hypochlorite solution. Resolution "D" establishes employment of Karen Davis as Business Administrator. Resolution "E" awards a contract for the Roll Off Container Truck. Resolution "F" is to advertise public notice of the solicitation of professional service proposals. Resolution "G" will be tabled and an explanation will follow. Resolution "H" authorizes disposal of surplus property through Gov Deals.

In closing, the Director thanked the Deputy Director Michael Fernandez, Business Administrator Karen Doran Davis and Administrative Assistant Patti McAllister for their help with his report this month.

Engineer

Mr. Harris reported the Upper Deerfield (Seabrook) Pumping Station has reached the end of its useful life and is in need of varying degrees of improvement. It has been identified as a priority project in the Authority's Capital Improvement Program. CME Associates has completed a draft assessment of the facility and recommended improvements to increase operating efficiency. The recommendations have been discussed with CCUA Staff. A final report will be prepared shortly incorporating Staff comments.

Mr. Harris also reported inspections of the Authority's Treatment Plant and Pump Stations were conducted on September 30, 2014 by CME Associates along with CCUA staff in order to gather information to be used in preparing the Engineer's Annual Report for 2014 and in updating the Authority's Capital Improvement Plan. A draft Annual Report and Capital Plan will be submitted to Authority Staff for review. The final Annual Report is required to be submitted to the Bond Trustees not earlier than 60 days and not later than 45 days before the end of the fiscal year (12/31/2014). We anticipate this time frame will be met.

Lastly, Mr. Harris reported that CME Associates assisted CCUA Staff in submitting a Letter of Intent and Planning Document to the NJ Environmental Infrastructure Trust as a first step in securing funding in the State Fiscal year 2016 funding cycle. Included in the submittal were projects for rehabilitation of the Upper Deerfield Pump Station and miscellaneous improvements to the Wastewater Treatment Plant.

Auditor

Mr. Testa was excused from this meeting and there was no report.

General Counsel

- Mr. O'Donnell reported that a consent order was prepared to dismiss without prejudice the contractor individual in the lawsuit.
- Mr. O'Donnell also reported that he met with the Employee Relations Committee and Administrative staff for negotiations.
- Mr. O'Donnell stated that he was available for any questions or concerns by staff and commissioners.

A RESOLUTION AUTHORIZING THE INTRODUCTION OF THE 2015 BUDGET

WHEREAS, the Annual Budget and Capital Budget for the Cumberland County Utilities Authority for the fiscal year beginning January 1, 2015 and ending December 31, 2015 has been presented before the Commissioners of the Cumberland County Utilities Authority at its open public meeting of October 16, 2014; and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$6,456,841 and Total Appropriations of \$6,596,841, and Total Unrestricted Net Position utilized of \$140,000; and

WHEREAS, the Capital Budget as introduced reflects Total Appropriations of \$440,000, Total Unrestricted Net Position planned to be utilized as funding thereof, is \$140,000 and Renewal & Replacement Reserve is planned to be utilized as funding thereof, of \$300,000; and

WHEREAS, the schedule of rates, fees and other charges in effect will produce sufficient revenues, together with all other anticipated revenues to satisfy all obligations to the holders of bonds of the Authority, to meet operating expenses, capital outlays, debt service requirements, and to provide for such reserves, all as may be required by law, regulation or terms of contracts and agreements; and

WHEREAS, the Capital Budget/Program, pursuant to N.J.A.C. 5:31-2, does not confer any authorization to raise or expend funds, rather it is a document to be used as part of the said Authority's planning and management objectives. Specific authorization to expend funds for the purposes described in this section of the budget, must be granted elsewhere, by bond resolution, by a project financing agreement, by resolution appropriating funds from the Renewal and Replacement Reserve or other means provided by law.

NOW, THEREFORE, BE IT RESOLVED by the Commissioners of the Cumberland County Utilities Authority as follows:

1. At a open public meeting held on October 16, 2014, that the Annual Budget, including appended Supplemental Schedules, and the Capital Budget of the Cumberland County Utilities Authority for the fiscal year beginning January 1, 2015 and ending December 31, 2015 is hereby recommended for approval; and

2. That a Public Hearing on the 2015 Budget be scheduled at the November 24, 2014 open public meeting of the Authority, notice of which will be published in the South Jersey Times (formally Bridgeton Evening News) at least twenty (20) days prior to the date of the Public Hearing, after which it will be scheduled for adoption.

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget and Capital Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Authority's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the members of the Cumberland County Utilities Authority will consider the Annual Budget and Capital Budget for adoption on December 18, 2014.
